**Committee Reports:**

**MR. BRYANT:** Mr. President I do.

**PRESIDENT SCOTT:** Mr. Bryant.

**MR. BRYANT:** Thank you Mr. President. I just have a brief safety update for anyone who wasn't in attendance for the special meeting that we has on 7/16, I think that was the date, it was a special Committee Meeting on gun violence in Mansfield. And I would like to thank Chief and Assistant Chief and leadership within the Police Department for joining us that night and giving an excellent presentation. Thank you so much for that information and also to other community leaders who shared with us that night. Two items were discussed, and brought forward from this meeting; the first is to strengthen outreach and involvement and support for the Mansfield Deterrence Program. That's a really good program we would like to keep that us and continue that. The second was support for allowing the hire of Mansfield Police Department Officers for certain establishments within the City of Mansfield; we

could explore that possibility moving forward. Um, we all pretty much supported that here at the meeting so, look forward to that being in the conversation in the future.

### **AMENDING CODIFIED ORDINANCES OF 1976: DEMOLITIONS**

**BY: MR. LAWRENCE**

**First Read**

**Bill# 19-035**

**Ordinance # 19-035**

Amending Sections 1335.17 and 1335.20 of the Mansfield Codified Ordinances of 1976 and 2013 concerning the demolition of structures in the City of Mansfield.

**DISCUSSION:**

**MR. FALQUETTE:** Mr. President this is something that I had brought up many months ago to strike out a section about leaving materials behind, and it was directly a result of the Trimble Road; used to be a meat market place, and there was piles of rubble left behind. Another part of that was the surface was supposed to be removed two feet below the surface, it still has the pad there. Apparently, there was no

building permit there and some of the reasons we brought this up was to try'n get that clarified. One of the things here on section II subsection a. in the paragraph was leaving the debris behind with "Breuer approval" and my concern is that this leaves it open for interpretation of the Inspector or the Breuer. I think it, maybe, leaves it open for appearance, not making any suggestions that anybody wouldn't be completely above the board working for the City, but the appearance that there may be favoritism that the Breuer may side one time to leave material and may side another time not to leave material. Where if it was just the rule that it was gone then there wouldn't be any soft spot here. So that's my concern with not striking out "leaving behind demolition material" in it's entirety. Otherwise some of the other changes made a lot of sense. We had talked in a couple Sub-Committee meetings, I guess if you wanted to call them that, a couple people got together and we talked about allowing the contractor, in section I, paragraph c. a little more time to complete the demolition, but giving him more time we expect...it complete at the end of that time, hence, the higher penalty. We kind of felt that the penalties were so low that it was almost worthwhile to have that property as a rental space to keep the equipment there and we saw that again on the Tremble Road facility where there is at least one major piece of demolition equipment left on Tremble Road for many, many, months and it cause a lot of consternation with the residents in that area, so thank you for your time and... (inaudible).

**PRESIDENT SCOTT:** Any other discussion? Mr. Jefferson?

**MR. JEFFERSON:** Just following information, you talking North Tremble Road or South Tremble Road?

**MR. FALQUETTE:** South Tremble Road, very close to Lexington Ave. then it was...

**MR. JEFFERSON:** Miller Meats...

**MR. FALQUETTE:** ... Miller Meats...

**MR. JEFFERSON:** Yeah, I think I know...

**MR. FALQUETTE:** Yeah...

**MR. JEFFERSON:** I just wanted to know 'case Tremble Road's a big place...

**MR. FALQUETTE:** Sure!

**PRESIDENT SCOTT:** Any other...

**MS. TADDIE:** Yes.

**PRESIDENT SCOTT:** Ms. Taddie?

**MS. TADDIE:** Well, I would love to get as much rubble out of my neighborhood as possible. It really feels like Sarajevo, because there's a number of poorly demolished buildings, standing, or, not standing; rubble, literally rubble. Um, is there a reason that you wanted, if you don't mind, if I could put you on the spot Marc...

**MR. MARC MILLIRON:** Well that what I'm here for.

**MS. TADDIE:** Tell us why you feel you need the flexibility, or why are we not pulling that put completely?

**MR. MARC MILLIRON:** Um, that's just based on if there would be some type of a possible, future, putting this off to the side, this is what I'm working on...uh, you know, there's a limited time...'cause if you go to the section, the next section, of .20, in there it states that unless you have intentions of building another structure it must be green afterwards...

**MS. TADDIE:** Mhhmmm.

**MR. MARC MILLIRON:** ... Seed and straw. So .20 kind adjusts that back, you know, so that the rule that's in there...(Inaudible)... Sub-section I, so... .20, kinda I don't want to say contradicts it, but it actually kinda provides more answers to that as far as, you know, drainage does need to come in unless you know...we've got one that's being demolished and they're going to build an Advanced Auto in there so... we have that other subject...um...keep in mind too, the fact that the PRIDE money and Land Bank is um, I want to say, kind of separated from this, because we have contracts with those contractors, you know that actually have to get this stuff done, per the contract, using PRIDE money, where in this situation...(inaudible).. Tremble, the problem there, that was a private demo...

**MS. TADDIE:** Right.

**MR. MARC MILLIRON:** ...and that's a little harder sometimes to regulate what they're doing out there cause, you know they just come in to get a permit to demolish it, we go out and do an inspection to make sure it's through closing and things are done. So that's kinda the grey area we had with the demolitions, was the PRIDE individuals, but the um, currently, right now with PRIDE and LANDBANK those area all under contractual. So, we have in a contract how those are taken care of and done properly.

**MS. TADDIE:** Umhm, and it's just like you said, I won't name names, but factories literally a stone's throw from my house, they they were taken down by private businesses and sometimes they even run, continue to run, business with the rubble fenced in, keeping, with barbed wire keeping the neighbors out, so, umm. As it stands this has been in place without the red changes, it's been place many years, right?

**MR. MARC MILLIRON:** It has. Yeah.

**MS. TADDIE:** So, how does a business, say, within the last five years get to tear down their property and leave it with rubble and not covered in green space, cinder blocks in pieces, actual pieces of brick...umm, floor grates still in the floor where the shop floor used to have grates. There's wetland plants, cattails and things growing out of there. Umm...

**MR. MARC MILLIRON:** Right. You're talking about what were left at certain areas?

**MS. TADDIE:** Yeah, I'm saying, how did that pass Code, if this is the standard of what the site's supposed to look like...

**MR. MARC MILLIRON:** Right. Right.

**MS. TADDIE:** Can we do any Retro...

**MR. MARC MILLIRON:** I and I can't go back because I don't know for certain if they presented something with the Planning Commission or the Commission...or...

**MS. TADDIE:** Yeah.

**MR. MARC MILLIRON:** To answer that question for you, I'm not sure...

**MS. TADDIE:** We can...

**MR. MARC MILLIRON:** ... How that was put together...

**MS. TADDIE:** We can follow up on that outside this venue. I appreciate your time.

**PRESIDENT SCOTT:** Any other questions discussion on 19-035?

**MR. JEFFERSON:** Yes.

**PRESIDENT SCOTT:** Mr. Jefferson.

**MR. JEFFERSON:** I Do. Mr. Falquette, Mr. Falquette, what were you implying when you were saying when you were talking about the rubble over there on Tremble Road. You wanted something done differently?

**MR. FALQUETTE:** I would preferred that the rubble was removed immediately.

**MR. JEFFERSON:** Okay.

**MR. FALQUETTE:** ...And it's now apparent, there was no plan to build anything. There wasn't any hole to fill in to push the rubble into. The pad hasn't been removed they haven't built another building on top of it and had we enforced this a little stronger, I think the "Private" individual trying to control his contractor would have had a little more Ordinance behind him to say, "you haven't finished the job yet."

**MR. JEFFERSON:** So, what are you suggesting we tighten up here?

**MR. FALQUETTE:** I still would just, just, that, that um, "Contractor resident under section has removed all lumber, rubble, other building structure debris, all from the grated premises..." Period.

**MR. JEFFERSON:** Okay.

**MR. FALQUETTE:** And as far as any owners request or gray area with the Bureau or anything like that, just move that.

**MR. JEFFERSON:** Okay.

**MR. FALQUETTE:** And this all changes if a person has a building permit to continue to move forward.

**MR. JEFFERSON:** So, oh. Okay. I see what you're sayin' I'm readin' that... "at the owner's request and Bureau approval", you like that removed, huh?

**MR. FALQUETTE:** Yes. Because it was possible that the owner said, "yeah, you can leave that pile of rubble there"; then everybody's lookin' at a pile of rubble, and in this case it was at least a year sitting there.

**MR. JEFFERSON:** Alright. I understand that. Thank you.

**LAW DIRECTOR SPON:** Mr. President if I may add...

**PRESIDENT SCOTT:** Director Spon.

**LAW DIRECTOR SPON:** ...There is no time limit stated...the Courts, traditionally, uh, infer that thirty days is a reasonable period of time and anything beyond thirty days is unreasonable.

**MR. FALQUETTE:** Sure.

**MR. LAWRENCE:** Hm.

**PRESIDENT SCOTT:** Any further discussion?

**MR. BRYANT:** Mr. President are we taking action?

**PRESIDENT SCOTT:** That's what I was...It's up to Council on tis one...

**MR. FALQUETTE:** Is a Council, or, or, just a ...

**MR. LAWRENCE:** This is just a First Read....would we have to...

**PRESIDENT SCOTT:** Yeah, this is just the First Read...

**MR. LAWRENCE:** ...And it was amended already. I mean would have to take it back to Council?

(Lots of voices talking at once)

**MR. LAWRENCE:** Take it back to Committee?

**PRESIDENT SCOTT:** We can amend it again. Now.

**MR. FALQUETTE:** ...And keep going. We could amend it tonight and keep going on it.

**MR. JEFFERSON:** We have three reads.

**MS. TADDIE:** Keep the readings.

**PRESIDENT SCOTT:** 'Cause we got the second read on the...

**MR. LAWRENCE:** ...Yeah, the 20<sup>th</sup>...

**PRESIDENT SCOTT:** ...The 20<sup>th</sup>... it's not passed until....

**MR. FALQUETTE:** September 3<sup>rd</sup>.

**PRESIDENT SCOTT:** ...The 3<sup>rd</sup> of September.

**MS. TADDIE:** How would you feel about that, Mr. Milliron?

**MR. MARC MILLIRON:** I, I have no, no, issues with taking that out of there. It really (inaudible), we're creating some other thing that the next person along the line's gonna have...(Inaudible)... so removing that is, is real good.

**MS. TADDIE:** Alright. Let's do it. I'll make a motion.

**MR. FALQUETTE:** I'll second it.

**MS. TADDIE:** To remove everything after the...

**MR. JEFFERSON:** Wait a minute! This is Mr. Lawrence's Bill isn't it?!

**MS. TADDIE:** Oh, sorry...

**MR. LAWRENCE:** That's fine if you Motion..., I mean um, so we're Motioning that we take out "at the owners request" and "at the Bureau's approval" correct?



**MS. TADDIE:** Everything after that...

**PRESIDENT SCOTT:** I was gonna say I want...

**MR. LAWRENCE:** Everything after...you want it to be...

**PRESIDENT SCOTT:** ...I want to make a Motion... I want to know what the Motion is.

**MR JEFERSON:** (Laughs).

**MR. LAWRENCE:** The Motion is; to put a period after “premises” and remove “at the owners request and the Bureau approval”. That to be...

**MR. FALQUETTE:** All the way...all the way to the end... All the way to the end of the paragraph.

**MR. LAWRENCE:** All the way to the end?

**MS. TADDIE:** Mhmm.

**PRESIDENT SCOTT:** Just, the whole thing ends after “premises”.

**MS. TADDIE:** “Premises”.

**MR. FALQUETTE:** “Premises.” Would be a period through section a).

**MS. TADDIE:** Yes.

**MR. FALQUETTE:** Is that what the Chair is Moving?

**MS. TADDIE:** I would, make a Motion, that we, in section 2 sub-section a), that we scratch, “or at the owner’s request and with Bureau approval, had piled it neatly upon the premises in such a manner as not to constitute a public nuisance, hazard, or possible rodent harborage.” That just goes completely. There’s no, no stacking or storing neatly or otherwise.

**PRESIDENT SCOTT:** Okay, it's been Moved and seconded. I won't repeat the Motion, but I think everybody's clear. Is there anybody... at this point is there any discussion on the Motion?


The bill was declared passed, signed by the President, approved by the Mayor and attested by the Clerk.
