

## REGULAR COUNCIL MEETING Jan 2<sup>ND</sup>, 2019

The first monthly meeting of Mansfield City Council met on Tuesday, Jan 2<sup>ND</sup>, 2019 at 7:30 PM in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Councilman Lawrence led the audience in prayer.

**ROLL CALL:** The following answered present at roll call: Falquette, Rock, Van Harlingen, Jefferson, Lawrence, Bryant, and Mears. Upon motion made to by Mr. Lawrence and seconded by Mr. Rock, President Scott was excused.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

### SUSPEND RULES

**MR. ROCK:** With respect to all bills 19-006 and 19-007 that the rule requiring legislation be submitted by Monday at 4pm, be suspended and that all bills 19-006 and 19-007, be allowed on the floor tonight, seconded by Mr. Falquette. The vote was taken and resulted as follows: Ayes: 6, Nays: 1 – Falquette.

#### AMEND SEC 137.01 OF CH 137 DEPT OF PUBLIC SAFETY & SERVICE

**ORDINANCE 18-257**

**BILL 18-260\***

Amending Section 137.01 of Chapter 137 (Department of Public Safety and Service) of the Mansfield Codified Ordinances of 1983, as amended.

**MR. LAWRENCE:** I will be voting no on this bill, with the hopes that the administration will be moving quickly to find a Human Resource Director.

**RENEWING SAFETY LEVY (1/2%) JAN 1, 2020 ENDING DEC 31, 2023**

**ORDINANCE 19-006\***

**BILL 19-006\***

Amending Chapter 191 of the Mansfield Codified Ordinances of 1997, as amended, to provide for the continuing levy of the existing one-half percent (1/2%) municipal income tax, after approval of such renewal levy by the electors pursuant to 718.01 of the Revised Code of Ohio, upon income taxable by the City of Mansfield for a period of four (4) years and commencing January 1, 2020 and ending December 31, 2023, being for the purpose of operating costs in the police and fire departments, and declaring an emergency.

**MAYOR THEAKER:** I would encourage Council and our citizens to get behind this and vote for this bill. This is definitely needed to power the safety services.

**MR. JEFFERSON:** I would agree. Tell your friends and family we need this to keep our safety forces.

Upon motion by Mr. Bryant that Bill 19-006 be read and placed upon the floor for discussion, seconded by Mr. Rock. The bill was placed upon the floor for final passage, seconded by Mr. Rock. The vote was taken and resulted as follows: Ayes: 7, Nays: 0.

**SUBMITTING THE QUESTION OF RENEWING SAFETY LEVY (1/2%)**

**BILL 19-007\***


Submitting the question of continuing the additional municipal income tax at the rate of one-half percent (1/2%) for a period of four (4) years from January 1, 2020 through December 31, 2023, to the electors of the City of Mansfield Ohio, for their approval or rejection at the primary election to be held within the City of Mansfield, Ohio, on May 7, 2019, with such additional income tax receipts continuing to be used for operating costs in the police and fire departments, and declaring an emergency.


**MR. FALQUETTE:** I always support the safety service personnel and hope all our citizens do to.
